## **Copying Guidelines for Employees**

The CLA Pharmaceutical Licence permits UK employees to make Paper or Digital Copies of content, subject to certain terms and conditions, from most books, magazines, journals and periodicals as well as from a wide range of digital publications. Copies may be made from publications including those to which you subscribe and from articles or press cuttings provided by licensed external suppliers where a copyright fee has been paid (e.g. from a PR or press cuttings agency or the British Library).

- Licence Coverage
  - Photocopying
  - Scanning
  - Copying of digital content, e.g. e-books, PDF files from electronic subscriptions, online journal articles and certain website material
- 2 What can I use copies for?
  - 2.1 Internal communications, for example:
  - · To share with colleagues at meetings or briefings
  - To share media coverage within your organisation
  - · For market intelligence
  - For research and development
  - 2.2 Paper or digital copies may also be sent to:
  - Healthcare professionals and others making unsolicited requests for therapeutic or technical information about a product\*
  - Regulatory authorities in any jurisdiction you may also send them to external regulatory advisers in connection with an application or regulatory advice
  - External advisers in connection with the preparation or prosecution of legal proceedings\*
  - Patent authorities in support of a patent application in any jurisdiction

**Important**: A copyright notice should be attached in all of the above scenarios. For clarity, copies may not be provided for any external marketing purpose.

3 How much can be copied?

On each occasion you may copy up to 5% of a publication, a single chapter of a book or two articles from a periodical, whichever is the greater. Where a periodical issue or a substantial part of it is dedicated to a particular theme, any number of articles dealing with that particular theme may be copied.\* For digital publications such as websites that are not conventionally structured, you should ensure that copying is limited to small extracts that are equivalent to these limits.

4 Who can make and receive copies?

Any UK employee in your organization including individual consultants or agency workers. UK employees, contractors and agency workers may send paper or digital copies to overseas employees (including affiliates and subsidiaries). When sending an electronic copy (e.g. a PDF) to an overseas recipient, the recipient may only print a single copy\* unless they have a local licence to allow further uses.

**5** Excluded Works

Please note that there are some individual titles, authors and categories of publications that are excluded from the Licence and you will need to contact the copyright owner directly for permission to copy these. To check if a work is excluded you can search for it on CLA's Check Permissions at cla.co.uk

6 Digital publications

Copying of electronic publications is restricted to publications published by Participating Digital Material Publishers. For full details please visit cla.co.uk

International publications
