Terms and Conditions

Introduction

The Copyright Licensing Agency (CLA) Library Licence provides a simple way in which photocopies of copyright material, made for commercial purposes in public libraries, can be made lawfully without seeking permission directly from the copyright owner in each case.

How the Library Licence works

You may purchase this licence from the librarian for a fee of **£22.50 (+ VAT)**. The licence permits you to make a single copy of an extract from a published work for commercial purposes. Before making a copy, please complete the attached form with the details of the work you are copying. This allows CLA to distribute the fee to the authors, publishers and visual artists whose work is reproduced. Please retain a copy of the form as this is also your VAT receipt. You are then permitted to make the copy make the copy on your behalf.

What may be copied?

You may copy from any book, magazine, journal or other periodical published in the United Kingdom unless it has been excluded from the licence by the rightsholder. To check whether a work is covered by the licence please go to **cla.co.uk** and check permissions by **Business**.

If you wish to copy from a work that was published outside the United Kingdom, you can do so if it was published in one of the following territories: Argentina, Australia, Austria, Barbados, Belgium, Canada (including Quebec), Chile, Denmark, Finland, France, Germany, Ghana, Greece, Hong Kong, Iceland, India, Ireland, Italy, Jamaica, Japan, Luxembourg, Malawi, Mexico, the Netherlands, New Zealand, Norway, the Philippines, Russia, Singapore, South Africa, South Korea, Spain, Sweden, Switzerland, Taiwan, Trinidad and Tobago, Turkey, the United States of America and Zambia. If the work was not published in one of these countries, the licence does not permit you to make a copy.

How much can I copy?

Each Library Licence authorises the photocopying of up to:

- One chapter in a book
- One whole article in a periodical (e.g. a journal or magazine)
- One report of a single case in a collection of law reports
- One poem in an anthology
- 5% of the book, periodical, collection or anthology in question

The purchase of this licence allows a single copy to be made and does not itself authorise any further copying.

This licence applies only to printed materials; it does not cover material available on the Internet, through digital subscriptions or on electronic media such as CD-ROMs.

This licence does not permit the making of a digital copy by scanning or photographing a published work.

Making further copies made under the Library Licence

Further copying (including the making or saving of an electronic copy and any downloading or printing out of the electronic copy) is permitted only if you have the permission of the copyright owner, or another CLA licence, that permits you to make further copies, or if the copying falls within one of the statutory exceptions to copyright. Indemnity

Provided you comply with these terms and conditions, CLA will indemnify you against any claim for copyright infringement. Subject to these conditions, CLA will take over responsibility for any negotiations for the settlement of any claim and if such claim cannot be resolved by negotiation CLA shall be entitled to assume full responsibility for the conduct of the defence of such claim. You must use all reasonable endeavours to ensure that all relevant correspondence is immediately forwarded to CLA and must ensure that no admission, offer, promise, payment or indemnity is made or given by you on behalf of CLA without CLA's written consent.

General

This licence shall be governed by English law and the parties agree to submit to the exclusive jurisdiction of the English courts as regards any claim or matter arising in relation to the Licence.

The parties do not intend that any term of the Licence shall be enforceable solely by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to the Licence.
